1. Introduction

This order contains the terms between us and you relating to our provision of AIForged to you or your customer. Definitions In this order:

annual subscription fee means the fee payable every 12 (twelve) months to access our product and excludes any processing credits necessary for processing activities. An annum will run from date of commencement for a period of twelve continuous months and is referred to as the annual subscription.

our product means AIForged, offered as software as a service and AIForged has the same meaning;

Processing credits means the tokens that your wallet will be credited with after payment is received by us to enable you to engage in processing activities in AIForged;

software as a service means the ability we provide to you to use our software via the agreed access methods as a service, and is also referred to as **AI Forged** or **our product**;

website means the website at the domain as may be designated by us or the application made available by us through Microsoft Store or any similar store that provides you with access to our product.

2. Duration

This order will start on the effective date and will continue for the period to which the annual subscription fee or any renewal thereof apply, unless terminated in accordance with the client relationship terms.

3. AIForged

- 3.1 **Basis.** We provide the software as a service on the basis as contemplated in our client relationship terms which are incorporated by reference and are available at <https://aiforged.com/ai-forged-customer-relationship-terms/>. You must provide our product to your customers on the same terms and must include this link in your order, quote and / or terms.

4. Fees

- 4.1 **Annual licence fee.** You will pay us the following software as a service licence fee annually in advance, based on the number of authorised users that will be using our product:

- 4.2 **Processing credits.** Each processing action has an associated fee for which you will have to purchase processing credits. Whenever you or a an authorised user uses our product to perform a processing action, we will deduct the relevant credits for the applicable processing action from the processing credits available in your account.

- Processing credits will expire 6 (six) calendar months after your / your customer's annual subscription has lapsed without being renewed. In case that the annual subscription is not renewed within 6 (six) months of expiry, the credits shall be forfeited and you / your client shall not be entitled to any compensation or claim in respect thereof.
- Additional processing credits may be purchased at any time provided that a valid annual subscription is in place.

- 4.3 **Fees covers software as a service.** Our agreed fees will cover the software as a service and not any other software or service, including any database.

- 4.4 **Increases.** If, after the effective date, the fees payable by you increase as a result of an increase by our integrated partners or annual increase, or where the parties agree to additional goods or services, you will pay us the additional fees agreed by the parties as being applicable.

- 4.5 **Additional Fees.** Additional fees will be agreed to in before incurred and will include:
